What is the purpose of this update?

This document tells you how SuperLife Growth has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Invests mostly in growth assets. Designed for investors that want a growth investment option. Negative annual returns may occur once in every 3-5 years on average.

Total value of the fund: \$22,316,748

Number of investors in the fund: 558

What are the risks of investing?

Risk indicator for SuperLife Growth



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


How has the fund performed?

Investors may also be charged individual action fees for specific actions or decisions (for example, for withdrawing money and transferring it to a KiwiSaver scheme other than the SuperLife KiwiSaver scheme). Small differences in fees and charges can have a big impact on your investment over the long term.

GST is included in the fund charges set out above.

Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$568 (that is 5.68% of her initial \$10,000). Jess paid other charges of \$12. This gives Jess a total return after tax of \$556 for the year.

The fund's foreign currency exposure may be hedged to the New Zealand dollar, and hedging levels will vary between 0% and 110%. As at 30 September 2019, 88.51% of the fund's foreign currency exposure was hedged.
