What is the purpose of this update?

This document tells you how the Ethica Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Invests in a mix of income and growth assets and designed for investors that want a balanced investment option. A socially responsible fund which excludes assets that do not meet the fund's defined ethical investment standards. Negative annual returns may occur once in every 5–7 years on average.

GST is included in the fund charges set out above.


Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$276 (that is 2.76% of her initial \$10,000). Jess paid other charges of \$12. This gives Jess a total return after tax of \$264 for the year.
