## SuperLife Growth Fund

#### Fund update for the quarter ended 30 June 2020

This fund update was first made publicly available on 28 July 2020.

## What is the purpose of this update?

This document tells you how the SuperLife Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## **Description of this fund**

Invests mostly in growth assets and designed for investors that want a growth investment option. Negative annual returns may occur once in every 3 – 5 years on average.

## What are the risks of investing?

#### Risk indicator for the SuperLife Growth Fund


## How has the fund performed?

## Annual return graph

Investors may also be charged individual action fees for specific actions or decisions (for example, for withdrawing money and transferring it to a KiwiSaver scheme other than the SuperLife KiwiSaver scheme). Small differences in fees and charges can have a big impact on your investment over the long term.

GST is included in the fund charges set out above.

#### **Example of how this applies to an investor**

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted of -\$288 (that is -2.88% of her initial \$10,000). Jess paid other charges of \$12. This gives Jess a total loss after tax of -\$300 for the year.

## **Currency hedging**

The fund's foreign currency exposure is hedged to the New Zealand dollar. The target hedging level is 80%. The actual hedging level can be anywhere in the 0% - 120% range. As at 30 June 2020, 79.40% of the fund's foreign currency exposure was hedged.
