#### Fund update for the quarter ended 30 September 2020

This fund update was first made publicly available on 29 October 2020.

## What is the purpose of this update?

This document tells you how the NZ Cash Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## **Description of this fund**

Invests in New Zealand cash (including term deposits) and designed for investors that want a defensive investment option that reflects the return (before tax, fees and other expenses) on the New Zealand cash market.

## What are the risks of investing?

#### **Risk indicator for the NZ Cash Fund**



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


## How has the fund performed?

This shows the return after fund charges and tax for each of the last 10 years ending 31 March. The last bar shows the average annual return since the fund started, up to 30 September 2020.

## Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$99 (that is 0.99% of her initial \$10,000). Jess paid other charges of \$12. This gives Jess a total return after tax of \$87 for the year.
