## What is the purpose of this update?

This document tells you how the NZ Mid Cap Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. ## **Description of this fund**

Invests in New Zealand shares and designed to track the return (before tax, fees and other expenses) on the S&P/NZX Mid Cap Index.

## Risk indicator for the NZ Mid Cap Fund



#### How has the fund performed?


#### **Example of how this applies to an investor**

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$75 (that is 0.75% of her initial \$10,000). Jess paid other charges of \$12. This gives Jess a total return after tax of \$63 for the year.
