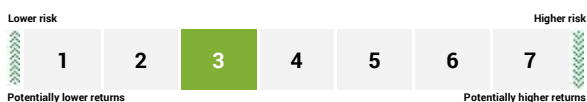
### Description of this fund

The S&P/NZX NZ Government Bond Fund invests in New Zealand bonds and designed to track the return (before tax, fees and other expenses) on the S&P/NZX NZ Government Bond Index.

### What are the risks of investing?

#### Risk indicator for the S&P/NZX NZ Government Bond Fund<sup>1</sup>



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

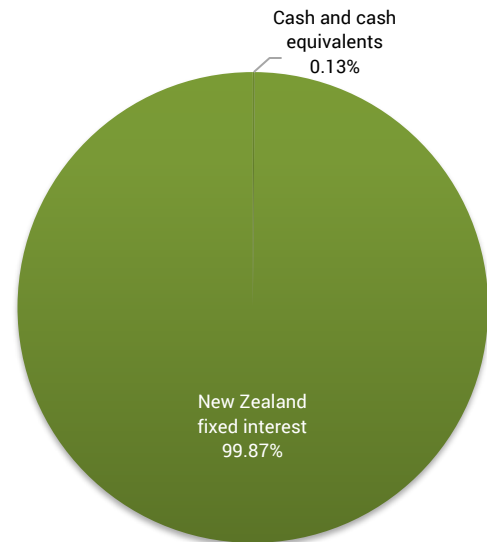
### Example of how this applies to an investor

Jess had \$10,000 in the fund on 15 July 2020 and did not make any further contributions. On 30 September 2020, Jess received a return after fund charges were deducted of \$173 (that is 1.73% of her initial \$10,000). Jess paid other charges of \$2 (Jess received statements and other SuperLife communications electronically and was not charged the paper statements fee). This gives Jess a total gain after tax of \$171 for the 2 months and 15 days.

## Notes
