# SuperLife Age Steps - Age 30

Investment update for the quarter ended 30 September 2020

This investment update was first made publicly available on 29 October 2020.

## What is the purpose of this update?

This document tells you how SuperLife Age Steps - Age 30 (the **stage**) has performed and what fees were charged. The document will help you to compare the stage with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## **Description of this stage**

SuperLife Age Steps automatically sets the proportion of your investment in income and growth assets based on your age. As you get older, the proportion of your investment in more volatile growth assets will be reduced, lowering the expected size of the ups and downs in the value of your investment. This option may be suitable if you are saving for retirement (assumed to be age 65), and assumes you will continue to invest your savings and spend them over your retirement period.

Your SuperLife Age Steps - Age 30 investment will be allocated 20.8% to income assets and 79.2% to growth assets.

# What are the risks of investing?

#### Risk indicator for SuperLife Age Steps - Age 30



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the stage's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Note that even the lowest category does not mean a riskfree investment, and there are other risks that are not captured by this rating.


#### How has the stage performed?

# Example of how this applies to an investor

Jess had \$10,000 in the stage and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of -\$78 (that is -0.78% of her initial \$10,000). Jess paid other charges of \$12. This gives Jess a total loss after tax of -\$90 for the year.
