### Fund update for the quarter ended 30 June 2021

This fund update was first made publicly available on 28 July 2021.

### What is the purpose of this update?

This document tells you how the S&P/NZX 50 Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this fund

The S&P/NZX 50 Fund invests in New Zealand shares and designed to track the return (before tax, fees and other expenses) on the S&P/NZX 50 Index.

### What are the risks of investing?

#### Risk indicator for the S&P/NZX 50 Fund<sup>1</sup>



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

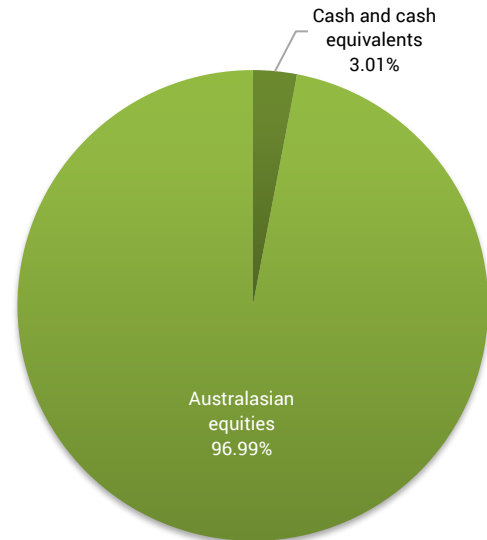
### Example of how this applies to an investor

Jess had \$10,000 in the fund on 15 July 2020 and did not make any further contributions. On 30 June 2021, Jess received a return after fund charges were deducted of \$907 (that is 9.07% of her initial \$10,000). Jess paid other charges of \$11. This gives Jess a total return after tax of \$896 for the 11 months and 15 days.

## Notes

- Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 4 years and 1 month of market index returns.
- We charge fixed fund charges that cover normal fund operating costs. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges.
- The administration fee in the year to 31 March 2021 is stated net of an income tax deduction that was applied in calculating your PIE tax payable (the deduction was paid to us). On 1 April 2021, we stopped doing this – this means the total fee you will now pay us will be lower.
