What is the purpose of this update?

This document tells you how the Global Property Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. 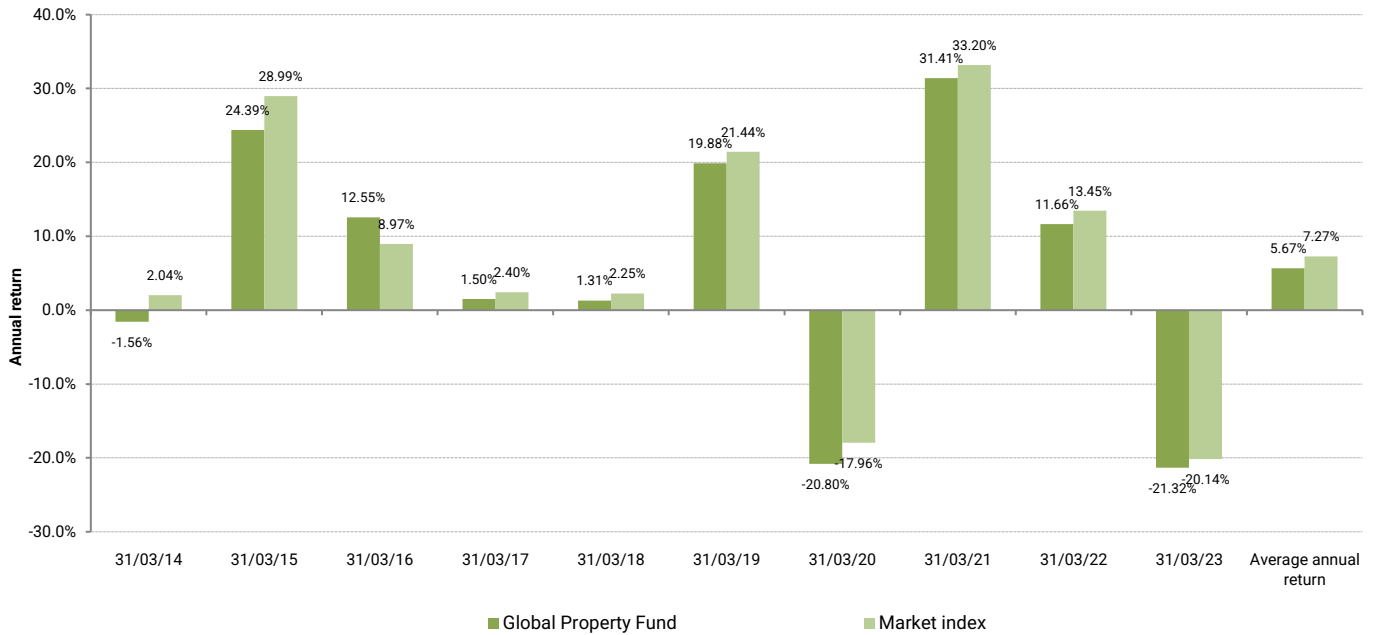

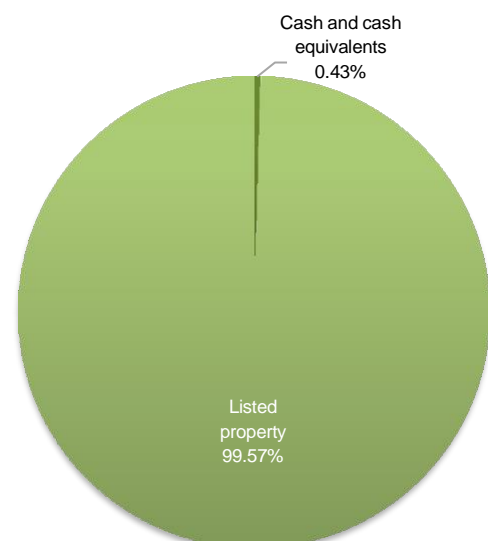
Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted but before tax of \$674 (that is 6.74% of Jess's initial \$10,000). Jess paid other charges of \$12. This gives Jess a total return after tax of \$567 for the year.

Currency hedging

As at 29 December 2023 the fund's exposure to assets denominated in foreign currencies was 74.51%, of which 97.16% was hedged. This means the fund's unhedged foreign currency exposure was 2.12% of the net asset value of the fund. Notes

- 1 These charges refer to the normal fund operating costs that are charged to the fund. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges. Some of these are fixed costs so the amount shown can range from 0% up to the total fund charges depending on the total value of the fund.
